RE: Public Speaking Time and Rebuttal.

Dear Mayor and Council Members,

The past 6 weeks have been a disgrace to our town after the council introduced and passed the Decorum and Speech Reduction Ordinances ("stifling ordinances"), which the majority of the public opposed ad nauseum. Our town that is rich in American History and a corner stone in the American Revolution is completely and utterly disgraced now by the Mayor and certain council members hasty actions to silence the public at council meetings.

The stifling ordinances, which have now completely backfired, are having the opposite effect right before your eyes.
